#### 1. INTENDED USE

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit is an in vitro nucleic acid amplification test for simultaneous detection of the DNA of Trichomonas vaginalis, Neisseria gonorrhoeae, and Chlamydia trachomatis in the clinical material (urogenital, rectal, and oropharyngeal swabs; eye conjunctival discharge; prostate gland secretion; and urine samples) by using real-time hybridization-fluorescence detection of amplified products.

The results of PCR analysis are taken into account in complex diagnostics of NOTE:

#### 2. PRINCIPLE OF PCR DETECTION

T.vaginalis, N.gonorrhoeae, and C.trachomatis detection by the multiplex polymerase chain reaction (PCR) is based on the amplification of the pathogen genome specific regions using specific *T.vaginalis*, *N.gonorrhoeae*, and *C.trachomatis* primers. In the real-time PCR, the amplified product is detected with the use of fluorescent dyes. These dyes are linked to oligonucleotide probes, which bind specifically to the amplified product during thermocycling. The real-time monitoring of fluorescence intensities during the real-time PCR allows the detection of accumulating product without re-opening the reaction tubes after the

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit is a qualitative test that contains the Internal Control (Internal Control-FL (IC)). It must be used in the extraction procedure in order to control the extraction process of each individual sample and to identify possible reaction inhibition.

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit uses "hot-start", which greatly reduces the frequency of nonspecifically primed reactions.

uses "hot-start", which greatly reduces the frequency of nonspectifically primed reactions. "Hot-start" is guaranteed by the separation of nucleotides and Taq-polymerase by using chemically modified polymerase (TaqF). The chemically modified polymerase (TaqF) is activated by heating at 95 °C for 15 min.

The PCR kit contains the system for prevention of contamination by amplicons using the enzyme uracil-DNA-glycosylase (UDG) and deoxyuridine triphosphate. The enzyme UDG recognizes and catalyzes the destruction of the DNA containing deoxyuridine, but has no effect on DNA containing deoxythymidine. Deoxyuridine is absent in the authentic DNA, but is always present in amplicons. Because deoxyuridine triphosphate is a part of dNTP. effect of DNA containing deoxynymioline. Deoxyuridine is absent in the authentic DNA, but is always present in amplicons, because deoxyuridine triphosphate is a part of dNTP mixture in the reagents for the amplification. Due to the deoxyuridine containing contaminating amplicons are sensitive to the destruction by UDG before the DNA-target amplification. So the amplicons cannot be amplified.

The enzyme UDG is thermolabile. It is inactivated by heating at temperature above 50 °C. Therefore, UDG does not destroy the target amplicons which are accumulated during PCR. The results of amplification are registered in the following fluorescence channels.

- must be used in the extraction procedure as Negative Control of Extraction. add 10  $\mu$ l of Internal Control-FL (IC) during the DNA extraction procedure directly to the sample/lysis mixture (see DNA-sorb-AM REF K1-12-100-CE protocol).

Variant FRT-100 F is intended for 110 reactions (including controls).

#### 4. ADDITIONAL REQUIREMENTS

- Disposable powder-free gloves and a laboratory coat.
- Pipettes (adjustable).
- Sterile pipette tips with aerosol filters (up to 200 µl).
- Tube racks.
- Vortex mixer
- Desktop centrifuge with rotor for 2-ml reaction tubes.
- Real-time instruments (for example, Rotor-Gene 3000/6000 (Corbett Research, Australia), Rotor-Gene Q (QIAGEN, Germany), iCycler iQ or iCycler iQ5 (Bio-Rad, USA), Mx3000P (Stratagene, USA)
- Disposable polypropylene PCR tubes (0.1- or 0.2-ml):
- a) 0.2-ml PCR tubes with optical transparent domed or flat caps if a plate-type instrument is used;
- b) 0.2-ml PCR tubes with flat caps or strips of four 0.1-ml Rotor-Gene PCR tubes if a rotor-type instrument is used.
- Refrigerator for 2 to 8 °C.
- Deep-freezer at the temperature from minus 24 to minus 16 °C.
- Reservoir for used tips.

#### 5. GENERAL PRECAUTIONS

The user should always pay attention to the following:

- Use sterile pipette tips with aerosol filters and use a new tip for every procedure
- Store all extracted positive material (specimens, controls and amplicons) away from all other reagents and add it to the reaction mix in a distantly separated facility.
- Thaw all components thoroughly at room temperature before starting an assay When thawed, mix the components and centrifuge briefly.
- Use disposable protective gloves and laboratory cloths, and protect eyes while samples and reagents handling. Thoroughly wash hands afterwards.
- Do not eat, drink, smoke, apply cosmetics, or handle contact lenses in laboratory work
- Do not use a kit after its expiration date.
- Dispose of all specimens and unused reagents in accordance with local regulations.
- Samples should be considered potentially infectious and handled in biological cabinet in compliance with appropriate biosafety practices.

  Clean and disinfect all samples or reagents spills using a disinfectant, such as 0.5 %
- sodium hypochlorite or another suitable disinfectant.

  Avoid inhalation of vapors, samples and reagents contact with the skin, eyes, and
- mucous membranes. Harmful if swallowed. If these solutions come into contact, rinse the injured area immediately with water and seek medical advice if necessary.
- Safety Data Sheets (SDS) are available on request.
  Use of this product should be limited to personnel trained in DNA amplification techniques.
- Workflow in the laboratory must be one-directional, beginning in the Extraction Area and moving to the Amplification and Detection Area. Do not return samples, equipment and reagents in the area where the previous step was performed.



Some components of this kit contain sodium azide as a preservative. Do not use metal tubing for reagent transfer.

#### 6. SAMPLING AND HANDLING

Obtaining samples of biological materials for PCR-analysis, transportation and NOTE: storage are described in the manufacturer's handbook [1]. It is recommended that this handbook is read before starting work.

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit is intended for analysis of the DNA extracted with DNA extraction kits from the clinical material (urogenital swabs, rectal swabs, oropharyngeal swabs, eye conjunctival discharge, prostate gland secretion, urine (use the first portion pellet of morning urine))

#### 7. WORKING CONDITIONS

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit should be used at 18–25 °C.

#### 8. PROTOCOL

#### 8.1. DNA extraction

It is recommended to use the following nucleic acid extraction kits:

- DNA-sorb-AM REF K1-12-100-CE.
- For other nucleic acid extraction kits see Guidelines [2]

The DNA extraction of each test sample is carried out in the presence of Internal Control-FL (IC).

Extract DNA according to the manufacturer's protocol NOTE:

#### 8.2. Preparing PCR

#### 8.2.1. Preparing tubes for PCR

The type of tubes depends on the PCR instrument used for analysis. Use disposable filter tips for adding reagents, DNA and control samples into tubes

#### Variant FRT-100 F

The total reaction volume is 25 µI, the volume of DNA sample is 10 µI.

1. Thaw the required number of tubes with PCR-mix-2-FRT. Vortex the tubes with PCR-mix-1-FL *T.vaginalis* / *N.gonorrhoeae* / *C.trachomatis*, PCR-mix-2-FRT, and polymerase (TaqF) and then centrifuge briefly.

Take the required number of tubes/strips for amplification of the cDNA obtained from

clinical and control samples.

For N reactions (including 2 controls), add to a new tube:

10 (N+1) µl of PCR-mix-1-FL T.vaginalis / N.gonorrhoeaea / C.trachomatis, 5.0 (N+1) µl of PCR-mix-2-FRT, 0.5 (N+1) µl of polymerase (TaqF)

Vortex the tube, then centrifuge it briefly. Transfer **15 μI** of the prepared mixture to each tube.

- Steps 3 and 4 are carried out in both variants.

  3. Using tips with aerosol filter, add 10 µI of DNA samples obtained at the DNA extraction stage.
- Carry out the control amplification reactions:
- NCA Add 10 µl of DNA-buffer to the tube labeled NCA (Negative Control of Amplification)
  - Add 10 µl of Positive Control complex to the tube labeled C+ (Positive Control of Amplification)
- C-Add 10 µl of the sample extracted from the Negative Control (C-) reagent to the tube labeled C- (Negative control of Extraction)

#### 8.2.2. Amplification

1. Create a temperature profile on your instrument as follows:

Fluorescent signal is detected in the channels for the FAM. JOE. ROX. and Cv5 fluorophores (other channels are enabled if several tests are simultaneously carried out in a single run).

- 2. Adjust the fluorescence channel sensitivity according to Important Product Information
- Bulletin and Guidelines [2].
  Insert tubes into the reaction module of the device.
- Run the amplification program with fluorescence detection
- Analyze results after the amplification program is completed.

#### 9. DATA ANALYSIS

Analysis of results is performed by the software of the real-time PCR instrument used by measuring fluorescence signal accumulation in four channels:

- The signal of the *Trichomonas vaginalis* DNA amplification product is detected in the channel for the FAM fluorophore.
- The signal of the Neisseria gonorrhoeae DNA amplification product is detected in the channel for the JOE fluorophore.
- The signal of the Chlamydia trachomatis DNA amplification product is detected in the channel for the ROX fluorophore
- The signal of the IC DNA amplification product is detected in the channel for the Cy5 fluorophore.

Results are interpreted by the crossing (or not-crossing) the fluorescence curve with the threshold line set at the specific level that corresponds to the presence (or absence) of a Ct value of the DNA sample in the corresponding column of the results grid.

Principle of interpretation is the following:

- Trichomonas vaginalis DNA is detected if the Ct value is determined in the results grid in the channel for the FAM fluorophore. Moreover, the fluorescence curve of the sample should cross the threshold line in the area of typical exponential growth of fluorescence. **Neisseria gonorrhoeae** DNA is **detected** if the *Ct* value is determined in the results grid
- Neisseria gonormoeae DNA is detected if the Crvalue is determined in the results grid in the channel for the JOE fluorophore. Moreover, the fluorescence curve of the sample should cross the threshold line in the area of typical exponential growth of fluorescence. Chlamydia trachomatis DNA is detected if the Ct value is determined in the results grid in the channel for the ROX fluorophore. Moreover, the fluorescence curve of the sample should cross the threshold line in the area of typical exponential growth of
- Trichomonas vaginalis, Neisseria gonorrhoeae and Chlamydia trachomatis DNA is **not detected** in a sample if the *Ct* value is not determined (absent) in the channels for FAM, JOE and ROX fluorophores (the fluorescence curve does not cross the threshold line), whereas the Ct value determined in the channel for the Cy5 fluorophore is less than the boundary Ct value specified in the *Important Product Information Bulletin*. The result is **invalid** if the Ct value is not determined (absent) in the channels for Cy5 fluorophore and FAM, JOE, ROX fluorophores. In such cases, the PCR analysis should
- be repeated for corresponding sample.

Boundary Ct values are specified in the Important Product Information Bulletin NOTE: enclosed to the PCR kit. See also Guidelines [2]

The result of the analysis is considered reliable only if the results obtained for Positive and Negative Controls of Amplification as well as for the Negative Control of Extraction are correct (see Table 3).

#### 10. TROUBLESHOOTING

Results of analysis are not taken into account in the following cases:

- If the Ct value for the Positive Control of Amplification (C+) in the channels for the FAM and/or JOE and/or ROX fluorophores is absent or greater than the boundary Ct value, the amplification should be repeated for all samples in which Ct value is absent in the respective channel
- 2. If the Ct value is determined for the Negative Control of Amplification (NCA) and/or 2. If the Cr value is determined for the Negative Control of Amplification (NCA) and/or Negative Control of Extraction (C-) in the channels for the FAM and/or JOE and/or ROX fluorophores, the PCR analysis starting from the DNA extraction stage should be repeated for all samples in which Ct value is determined in the respective channel.

### 11. TRANSPORTATION

AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis-MULTIPRIME-FRT PCR kit should be transported at 2–8 °C for no longer than 5 days.

#### 12. STABILITY AND STORAGE

All components of the AmpliSens® *T.vaginalis / N.gonorrhoeae / C.trachomatis*-MULTIPRIME-FRT PCR kit are to be stored at 2–8 °C when not in use (except for polymerase (TaqF) and PCR-mix-2-FRT). All components of the AmpliSens® *T.vaginalis / N.gonorrhoeae / C.trachomatis*-MULTIPRIME-FRT PCR kit are stable until the expiration date stated on the label. The shelf life of reagents before and after the first use is the same, unless otherwise stated

PCR-mix-2-FRT and polymerase (TagF) are to be stored at the temperature NOTE: from minus 24 to minus 16 °C.

PCR-mix-1-FL T.vaginalis / N.gonorrhoeae / C.trachomatis is to be kept away NOTE:

from light.

Analytical sensitivity of the PCR kit in the case of each microorganism does not change even at high concentrations of two other microorganisms (to 10<sup>9</sup> GE/ml).

13.2. Specificity
The analytical specificity of AmpliSens® *T.vaginalis / N.gonorrhoeae / C.trachomatis* - MULTIPRIME-FRT PCR kit is ensured by the selection of specific primers and probes as well as stringent reaction conditions. The primers and probes have been checked for possible homologies to all sequences published in gene banks by sequence comparison analysis

analysis.

Nonspecific responses were absent in tests of human DNA samples and DNA samples of the following microorganisms: Gardnerella vaginalis; Lactobacillus spp.; Escherichia coli; Staphylococcus spp.; Streptococcus spp.; Candida albicans; Mycoplasma hominis; Ureaplasma urealyticum; Ureaplasma parvum; Mycoplasma genitalium; Chlamydia trachomatis; Neisseria spp.; Neisseria gonorrhoeae; Trichomonas vaginalis; Treponema pallidum; Toxoplasma gondii; HSV type 1 and 2, CMV, HPV.

The clinical specificity of AmpliSens® T.vaginalis / N.gonorrhoeae / C.trachomatis - MULTIPRIME-FRT PCR kit was confirmed in laboratory clinical trials.
